MAJIC 107.7'S "PIZZA AND A MOVIE " CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KMAJ-FM ("Station"), owned and operated by Cumulus Broadcasting LLC. located at 825 S Kansas Ave Suite 100, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Majic 107.7's "Pizza And A Movie"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

Eligibility. 2. Contest Period. The Contest will begin at 12:01am CT on September 25, 2020 and will run through 11:59pm CT on September 27, 2020 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.** To enter:

Send a text message with the keyword PAWS to 877-297-1077 during the Contest Period. All entries must be received during the Contest Period to be eligible for the Grand Prize drawing. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes.

4. Winner Selection. On Monday, September 28 on or around 10:00 AM CT, the Station will select ten (10) entries in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and

binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
