MAJIC 107.7'S "FACEBOOK" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 4. **Winner Selection.** On or about 8:00 a.m. on November 29, 2021, Station will select one (1) potential winner, in a random drawing from among all valid entries received by Station during the Contest Period. If only one person guesses the title and artist correctly, they will be identified as the potential winner. If multiple entries have guessed the correct title and artist, all valid entries will go into a random drawing to determine the winner from among all valid daily qualifying entries received by Station during the Contest Period for the Grand Prize drawing. The winning entrant will be contacted using the Facebook account used with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest.
