MAJIC 107.7'S "CALLER TO WIN" CONTEST OFFICIAL RULES

The Station will conduct the **Majic 107.7's "CALL TO WIN"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. Contest Period. The Contest entry period will begin Monday, December 20, 2021, and will run each weekday at about 7:35 a.m. and 8:35 a.m. through Thursday, December 23, 2021 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and Win.

Listen to the Station weekdays at about 7:35 a.m. during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners must call the Station at 877-297-1077. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name, phone number, date of birth, email address and mailing address, subject to verification and compliance with these Contest Rules. All entries may be play on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. LIMIT ONE PRIZE PER PERSON.

4. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
