MAJIC 107.7'S "EVERY 10 MINUTES PRIZE DRAWING" CONTEST OFFICIAL RULES

The Station will conduct the **Majic 107.7** "EVERY 10 MINUTES PRIZE DRAWING" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 2. **Contest Period.** The Contest entry period will begin at 5:00pm CST and will run through 7:00pm CST on September 26, 2023. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**
 - Remote Broadcast: Attend a remote broadcast conducted by Station on September 26, 2023, from 5:00pm through 7:00pm at Jefferson's, 2915 SW Wanamaker Rd, Topeka, KS 66614 and send a text message with the designated keyword given, spelled correctly, to 877-297-1077. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.
- 4. Winner Selection. On or about every ten (10) minutes on September 26, 2023, Station will [select one (1)] winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant(s) [must be present to win and will be contacted] using the telephone number provided with the entry or via PA system announcement and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner(s) are final and binding in all matters related to the Contest. Failure to respond to the initial verification will result in disqualification.

- 5. Verification of Potential Winner, THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. For entry to the prize event(s), each event attendee may be required to show valid proof of vaccination against the COVID-19 virus and/or valid proof of a negative test for the COVID-19 virus within 72 hours (or such other time as the event organizers require) prior to the event(s).
