MAJIC 107.7'S "CUE TO CALL" CONTEST OFFICIAL RULES

The Station will conduct the MAJIC 107.7's "CUE TO CALL" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. - 2. **Contest Period.** The Contest entry period will begin 8:00am CST and will run through 4:59pm CST on November 17, 2023. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- CST on November 17, 2023, when the Station plays "It's the Most Wonderful Time of the Year" by Andy Williams, listeners must call the Station at 877-297-1077. Caller number forty (40) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. LIMIT ONE PRIZE PER PERSON.
