MAJIC 107.7'S "TRILOGY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KMAJ-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.KMAJ.com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the MAJIC 107.7's "TRILOGY" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. At or around [9:00] CST [each weekday on December 18, 2023, through December 22, 2023] (each, a "Selection Day"), when the Station gives two correct song titles and one incorrect song title from Enrique Iglesias, Ricky Martin or Pitbull, listeners must call the Station at 877-297-1077. The first caller to the Station to correctly identify the incorrect song title, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.
