## MAJIC 107.7'S "TEXT TO WIN" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KMAJ-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.KMAJ.com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the MAJIC 107.7's "TEXT TO WIN" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, plus residents in the following Kansas counties are also eligible: Atchison, Leavenworth Douglas and Franklin, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. **Contest Period.** The Contest entry period will begin at 3:00pm on April 29, 2024, and will run [weekdays] through 4:00pm on May 3, 2024. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

Listen during the Contest Period. Station will announce designated keywords on-air [weekdays], (each a "Contest Round"). Then:

<u>Text</u>: Send a text message with the designated keyword(s), spelled correctly to 877-297-1077 no later than 11:59 p.m. CST that day. Participants may submit up to one (1) text message per day, for each keyword.

## OR

<u>Free Alternate Method of Entry:</u> To enter the Contest without sending a text message during the Contest Period, participants can visit the website <a href="https://amoe.textgroove.com/ff8aa610-1050-4cbe-a558-8dc1646550ca">https://amoe.textgroove.com/ff8aa610-1050-4cbe-a558-8dc1646550ca</a> and fully complete the Entry Form by (a) providing the keyword(s) spelled correctly (b) a telephone number (cell phone or landline), including area code, (c) email, (d) city, state, and zip code, and (e) name. Participants may only submit one (1) Entry Form per day.

Entries must be received by 11:59 p.m. CST the day the keywords are announced to be a valid entry. The final day's entries must be received by 11:59 p.m. CST on May 3, 2024, to be eligible to win. Participants can enter this Contest up to one (1) time per day. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Texting in the Entry will not improve a Participant's chances of winning. Limit one (1) entry per person per Contest Round, regardless of the method of entry chosen by a listener. Each Contest Round of the Contest, listeners may either (i) text in an entry into using a mobile device or (ii) enter online, but not both methods.

- 4. **Winner Selection.** On or about [10:00am] on May 6, 2024, Station will select four (4) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. Station and any Sponsors make no representation or warranty about the safety of any prize. - Entry Conditions and Release.
