## MAJIC 107.7'S "GOODCENTS KEYWORD" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KMAJ-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.KMAJ.com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the MAJIC 107.7's "TEXT TO WIN" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
  - Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, plus residents in the following Kansas counties are also eligible: Atchison, Leavenworth Douglas and Franklin, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 2. **Contest Period.** The Contest entry period will begin May 27, 2025 and will run weekdays 7:00am through 7:59am CST May 30, 2025. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** There are two ways to enter this contest.
  - 1. Listen during the Contest Period. Near or about 7:00am CST, when station gives the keyword followed by the cue-to-text sounder, (each, the "Sounder"), listeners must send a text message with the keyword spelled correctly to 877-297-1077 before 11:59pm CST that day. Limit one (1) text message per day, per phone number. **OR**
  - 2. Limit one (1) entry form per person, per day.

All entries must be received by 11:59 p.m. CST. The final day's entries must be received by 11:59 p.m. CST on May 30, 2025, to be eligible to win. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Texting entry will not improve a participant's chances of winning. Limit one (1) entry per person per day, regardless of the method of entry chosen. Per day of contest, listeners may either (i) text in an entry into using a mobile device or (ii) enter online, but not both methods.

- 4. Winner Selection. On or about 10:00am CST on June 3, 2025, Station will select five (5) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
